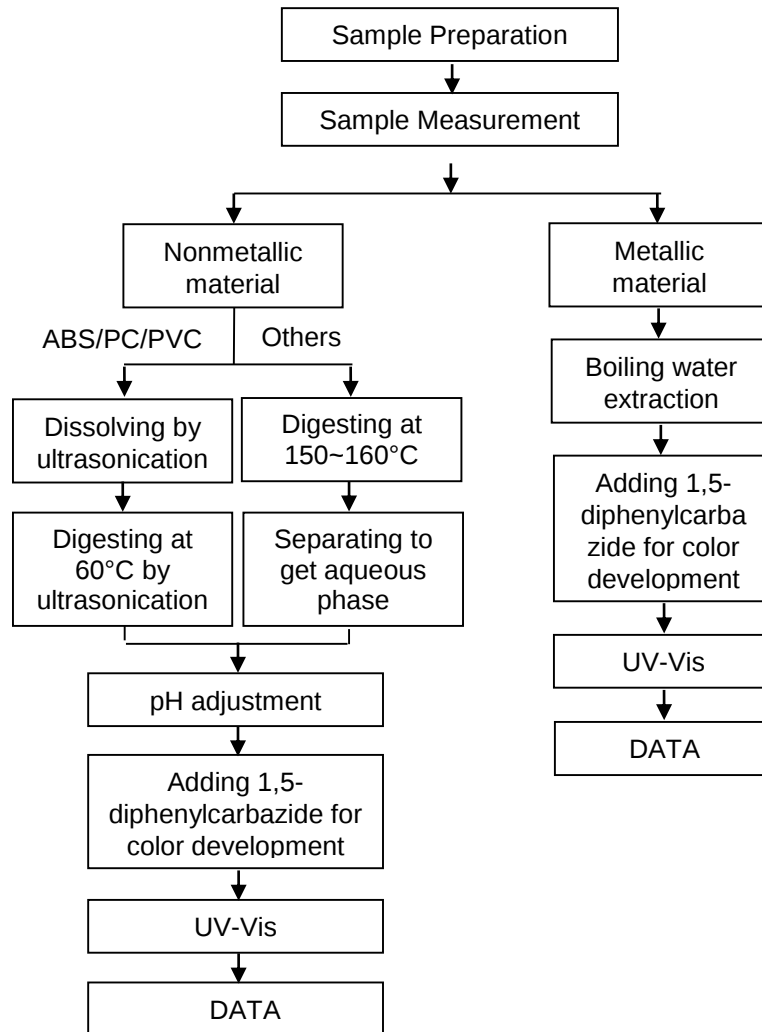

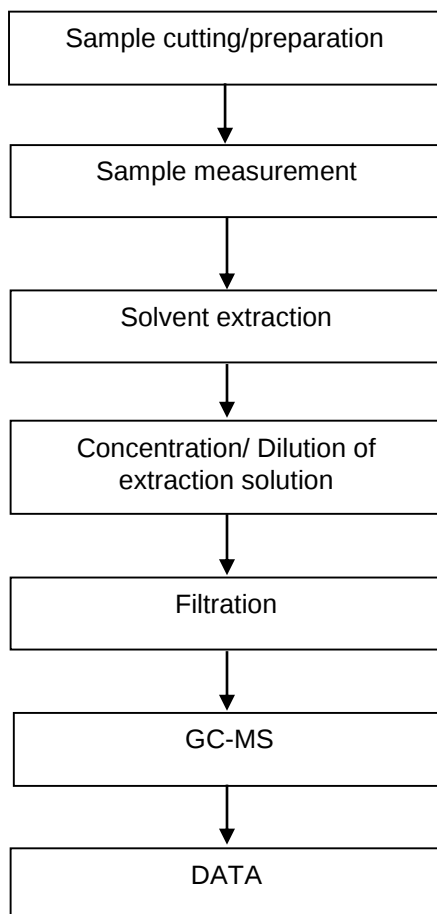

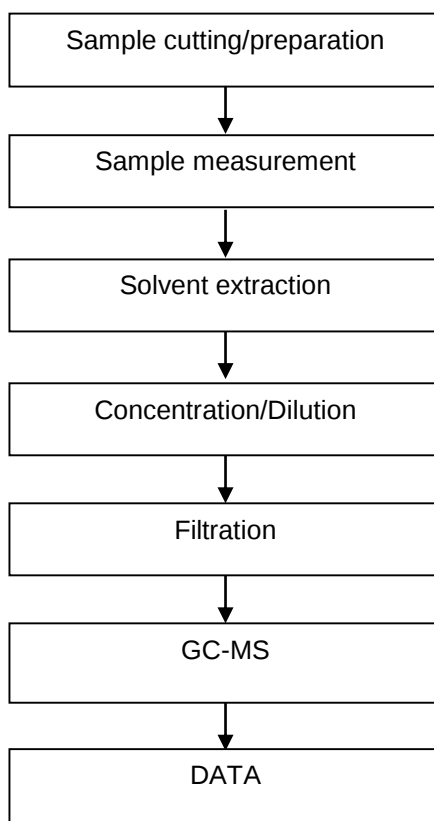

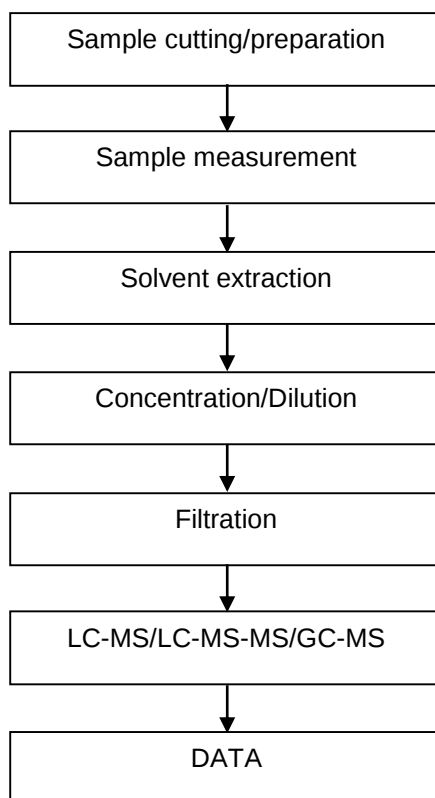

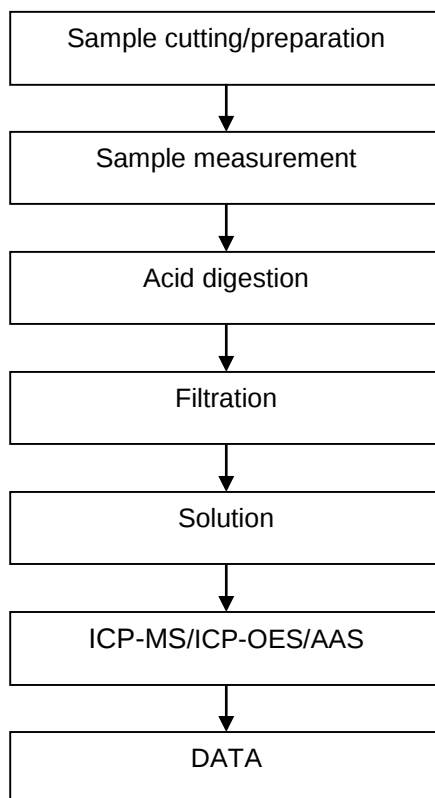
Phthalates Testing Flow Chart



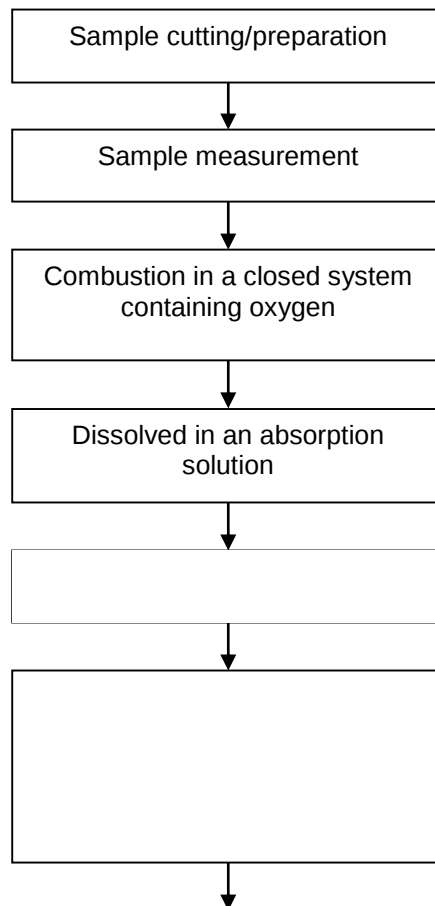
PFASs/ PFOS/PFOA Testing Flow Chart

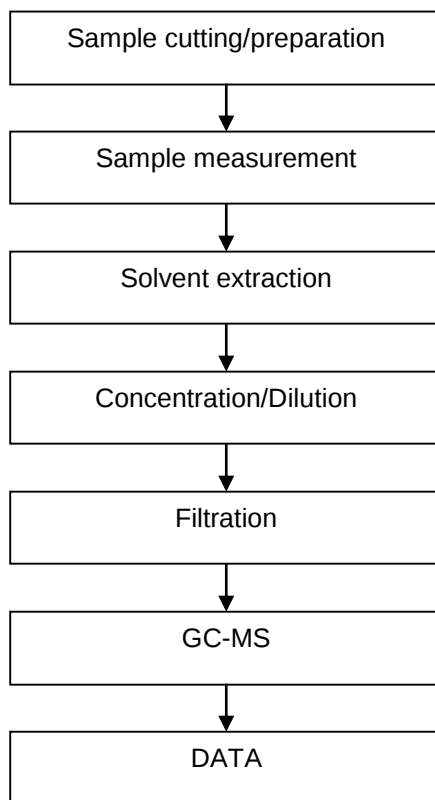

HBCDD Testing Flow Chart



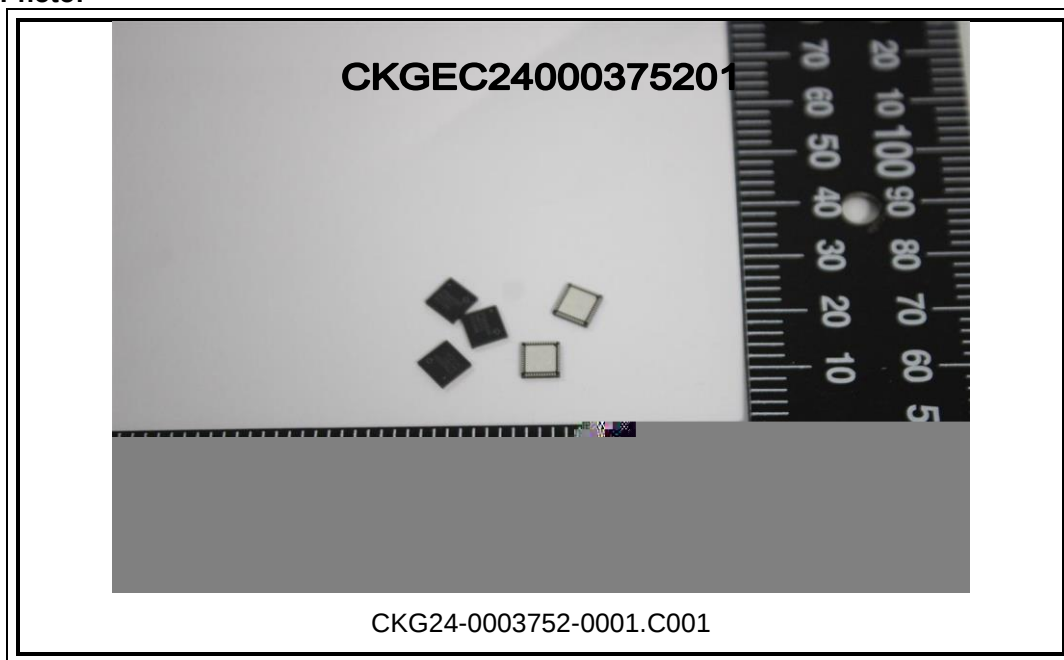
